A FY 2017-18 Joint Budget Work Session of the Lancaster County Board of Supervisors and the Lancaster County School Board was held in the Public Schools Annex Building of said county on Thursday, February 9, 2017.

Mr. Lee and Dr. Westbrook called the meeting to order.

BUDGET CONSIDERATION

Ms. Whitney Barrack, Finance Director for Lancaster Public Schools, stated that she wanted to go over some budget highlights. She referred to the expenditure side and stated that they wanted to give a 1.5 percent increase plus a step for all teachers and a three percent increase for all other staff. She stated that VRS has an increase of 1.66% and the Regional SPED tuition has been reduced by \$150,000. She stated that there is an increase in the dual enrollment tuition as well. She stated that, overall, the expenditures have been decreased by \$275,756.

Mr. Steve Parker, School Superintendent for Lancaster County, stated that an early college academy will allow high school students to take dual enrollment classes while attending Lancaster High School. He stated that the goal is for the class of 2019 to have 20 students receive their Associate's Degree before they graduate high school or shortly thereafter. He stated that this has been approved by the Department of Education.

He stated that another reason for the Dual Enrollment tuition increase is because Rappahannock Community College has raised its tuition.

Ms. Barrack referred to the revenue side of the school budget and stated that there is a projected decrease in state funding of \$73,322 and a projected decrease in federal funding of \$79,739. She stated that the decrease in other funding included the programs of Kids First and E-rate, which continue to shrink every year.

There was discussion about the percentage of state lottery funds going towards public education.

Ms. Barrack referred to teacher salaries and stated that her graph showed current salaries, proposed salaries and what other surrounding localities' salaries were.

CLOSED SESSION

Motion was made by Mrs. Gravatt for the School Board to enter into closed session. Mr. Palin made a motion to enter into closed session to discuss matters exempt from the open meeting requirements of the Virginia Freedom of Information Act. The subject matters to be discussed were Acquisition of Real Property, δ 2.2-3711.A.3 and Potential Award of Public Contract, δ 2.2-3711.A.29 of the Code of Virginia, 1950, as amended. The subject and purpose falls within the following exemptions under δ 2.2-3711.A.3 (discussion or acquisition of real property for a public purpose where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the School Board) and δ 2.2-3711.A.29 (discussion of the award of a public contract involving the expenditure of public funds, including interviews of bidders or offerors, and discussion of the terms or scope of such contract, where discussion in an open session would adversely affect the bargaining position or negotiating strategy of the School Board.)
