# PUBLIC HEARING - SCHOOL BOARD BUDGET

Chairman Jenkins opened the public hearing.

Mr. Charles Costello commended all individuals involved in the preparation of the FY07 annual budget; however, said he thinks 6.4% salary increase is too high and whenever the salary increase is decided, it should be across-the-board for all. He believes the Air Force Junior ROTC Program is a good program. He recommends two finance managers, one for the school system and one for the county, there should be a mid-year budget review, and put the school board budget online. Mr. Earle Bartholomew had concerns about taxes.

Mr. Tony Callahan stated he cannot support 20% increase in taxes and thinks Mr. Palin should recuse himself since he works for the school administration.

Mr. Howard Blank said he had questions about real estate figures.

Mr. Frank Smith had questions about the cost per student.

Mr. Alex Stickler said the cost of health insurance is too high; however, he supports the increase in teacher salaries.

Cabell Westbrook stated he is a teacher at Lancaster Middle School and believes the teachers should receive a salary increase.

Mr. Howard Kyzer said he has questions and concerns about the cost of public education and its relationship to real estate taxes.

Chairman Jenkins closed the public hearing.

#### **RESCIND LANCASTER COUNTY BURN BAN**

Mr. Pennell said, after consultation with Mr. Beauchamp, Lancaster County's Director of Emergency Services, he believes the burn ban should be rescinded as the county has received sufficient amount of rainfall to assuage the threat of wild fire.

**NOW THEREFORE BE IT RESOLVED,** that the emergency prohibition on open burning in Lancaster County adopted on March 27, 2006 is hereby rescinded.

**BE IT FURTHER RESOLVED,** that the Commonwealth of Virginia's 4:00 p.m. burning restriction remains in place until it expires on April 30, 2006.
