Dr. Russell called the meeting to order at 7:00 p.m.

### **PRESENTATIONS**

Lancaster High School 2010 Girls Basketball Team – Mr. Pennell stated the Lancaster
High school Girls Basketball Team had an extremely successful year during 2009-2010.
The young women were runners-up in the state tournament. He read the resolution of
commendation and Dr. Russell read some of their accomplishments.

Coach Webb-Fary stated that she was very excited and appreciated the Board of Supervisors recognizing the girl's basketball team. She explained that some of the girls were attending an academic banquet. She introduced each of the girls in attendance, giving a synopsis of their role on the team. ### **VIRGINIA DEPARTMENT OF TRANSPORTATION**

 Abandon VDOT Right-of-Way – Virginia State Highway 717 – Mr. Trapani stated the County of Lancaster recently received a request made by Mr. Lloyd B. Medlin and Mr. L. Bruce Medlin, Jr. to abandon Virginia State Highway 717 in front of their homes.

Mr. Trapani said he has not determined whether this road can be abandoned because there may be utilities located on the road. There would have to be a public hearing, and the Board would have to take action on the matter.

Mr. Pennell asked if an easement could be made in front of the property, planting grass and making the area look better.

Mr. Trapani said that making an easement is a possibility. He would have more information available for the May 27, 2010 Board of Supervisors meeting.

### New Communication List

Mr. Trapani stated he provided Mr. Pennell with a new communications list, as the reorganization within VDOT has begun. It has been both trying and interesting. When citizens from Lancaster County call the headquarters they will be speaking to someone at the call center in Salem, Virginia. Mr. Trapani is receiving the work requests that are generated, and he is contacting the concerned citizens.

## Primary Six-Year Plan

The Primary Six Year Plan public hearing will held on May 19, 2010 at the Central Office in Richmond. Mr. Trapani stated that Mr. Pennell has sent correspondence on behalf of the County to request consideration for a couple of small projects; one project requested was the left hand turn at VSH 3/VSH 604 Pinkardville Road and VSH 3/VSH 605 Regina Road. Mr. Trapani met with the Commonwealth Transportation Board representative, and she is aware of those locations. The Commonwealth Transportation Board is looking for small projects for the Primary Six Year Plan. It was thought that these two projects would be beneficial and that the Commonwealth Transportation Board might consider funding them. The Board of Supervisors does not need to attend the consideration meeting, as the correspondence is sufficient.

### **County-wide Maintenance**

Mr. Trapani stated regular maintenance consists of paving and pothole patching.

Mr. Jenkins said there are trees hanging into Millenbeck Road and that two cars cannot pass as a result. He requested that VDOT take corrective action.

Mr. Jenkins further stated that when Lee Highway Paving was paving VSH 201 and VSH 354, it was a big mess. They cannot handle the job without VDOT supervision. A different contractor is doing the line painting with no signs or people directing traffic. He requested that VDOT also take corrective action on this matter.

Mr. Pennell asked how many times VDOT would mow the primary system during this season.

Mr. Trapani stated they would mow one time for the year.

Mr. Pennell asked Mr. Trapani if he would continue to attend the monthly Board of Supervisors meeting.

Mr. Trapani said that he would as long as he is the liaison for the county.

### **PUBLIC HEARING**

Jacqueline Gibson – Application for Special Exception (Individual Manufactured Home)

 Mr. Gill presented an Application for Special Exception by Jacqueline Gibson to place an individual manufactured home on a 1.339-acre parcel described as Tax Map #21-85.
 This property is located on VSH 612 (Buzzards Neck Road) near its intersection with VSH 713 (River Ridge Road) and is in Voting District 2.

Mr. Gill said Ms. Gibson's individual manufactured home (32'X60' double wide) meets all of the requirements of the Zoning Ordinance Article 5-1-3 for "by right" placement EXCEPT "a roof pitch of 3.25:12 or greater" and therefore requires a special exception. The roof pitch, as stated by the applicant and verified with Clayton Homes, is only 3:12.

Mr. Gill stated this property would utilize the existing septic site and well. All front, rear and side setbacks can be met. Similar types of manufactured homes exist in this neighborhood.

Mr. Gill said this issue has been advertised and adjoining property owners notified as required by law. To date, there has been no input from adjoining property owners or other interested members of the public.

Chairman Russell opened the public hearing.

Hearing none, Chairman Russell closed the public hearing.

Mr. Palin made a motion to Approve the Application for Special Exception by Jacqueline Gibson to place an individual manufactured home on a 1.339-acre parcel described as Tax Map #21-85 located on VSH 612 (Buzzards Neck Road) near its intersection with VSH 713 (River Ridge Road).

 FY 2011 Lancaster County Public Schools Budget – Mr. Larson requested that the Board hold a public hearing on the proposed FY 2011 Lancaster County Public Schools Operating Budget and School Cafeteria Budget and approve the subject budgets as submitted or modified.

Code of Virginia, §22.1-93, states, "the governing body of a county shall prepare and approve an annual budget for educational purposes by May first or within thirty days of the receipt by the county of the estimates of state funds, whichever shall later occur." The Board has indicated their general satisfaction with the budgets at a previous meeting with members of the School Board and a work session in which Ms. Sciabbarrasi, Superintendent of School presented the budget.

Chairman Russell opened the public hearing.

Ms. Sciabbarrasi stated all schools meet state accreditation, the high school does offer dual enrollment whereas, and students can achieve an Associate Degree at the same time as their high school diploma. She said 48.65 % of high school graduates receive an advanced diploma. The Class of 2010 has post graduate plans as follows: (1) 47% will attend a four year college; (2) 27% will attend a two year college; (3) 9% will attend a trade school; (4) 7% will enlist in the military; and (5) 10% will enter the workforce. The Vocational Center offers state board certificates and industry standards certificates. She

stated the primary school asphalt parking and bus loop project has been completed, HVAC has been replaced, and all the classrooms have Smart Board. She further stated that security cameras, fire alarm and intercom systems at the middle school have been updated, and renovation of the field area (restrooms, entrance, concession stand and gate) has been completed at the high school. Also, district-wide, they are providing classrooms with 21st Century skills by upgrading Windows with the newest version of software.

Ms. Sciabbarrasi said in a 2008 Comparison by District that Lancaster County had the greatest percent of on-time graduation rate of 88% and the lowest dropout rate in regard to all students in the school at 5.6%. The on-time graduation rate is 6% higher than the state average and the dropout rate is 4.3% lower that the state average. She also stated that Lancaster County surpasses neighboring districts with 75.2% of students attending a two or four year college.

Ms. Sciabbarrasi asked the Board of Supervisors for an annual appropriation vice quarterly and that a lump sum appropriation be continued. She said they must pay Bright for each report requested to reflect quarterly appropriations. She said 75% of the budget is committed at the beginning of the year for contracts.

Mr. Jenkins asked if teachers who leave in the middle of the year before their contract expires tend to have a higher salary than the teacher hired to fill the remainder of the contract.

Ms. Sciabbarrasi said that if someone leaves middle year, which seldom happens, the new teacher's salary would likely be less, but could also be more depending on qualifications of the new teacher.

Mr. Jenkins said from past experience with the old administration a replacement would come in at a lower salary and that salary went somewhere else which was one of the reasons this board had opted for quarterly appropriations. He agreed that a large percentage of the school budget is tied to contracts, but not all of it. He stated all other

county departments have no problem working on a quarterly appropriation and that Ms. Sciabbarrasi has also achieved a high degree of efficiency and effectiveness in the school system working with quarterly appropriations.

Ms. Sciabbarrasi stated the proposed FY 2011 budget reflects a reduction of \$78,000 overall from the FY 2010 budget. They are able to do this and still fund an energy performance contract, one bus, textbook adoption, and \$85,000 that the county has previously funded for behavior aides. She also, stated that earlier in the week three teaching candidates were offered positions, and all three turned down the offer because of the salary.

Dr. Russell asked Ms. Sciabbarrasi if she believes we are not getting the best teachers because of salary.

Ms. Sciabbarrasi said he does not believe that is true; however; it does take longer and greater effort to meet staffing goals.

Dr. Russell said he agrees with Mr. Jenkins that the school budget is increasingly more efficient and effective. The School Board and the Board of Supervisors now have a great working relationship, and that was not the case a few years ago.

Mr. Jenkins stated he would prefer that the schools continue on a quarterly appropriation instead of the requested annual appropriation.

Mr. Costello stated he was happy to see both boards working together and that the budget process has become much smoother.

Being no further input, Chairman Russell closed the public hearing.

Mr. Geilich made a motion to approve the local contribution to the Lancaster County School Division Budget and Cafeteria in "lump sum" amount of \$10,256,808 for FY10-11. The budget would be funded as follows:

Mr. Geilich made a motion to approve the requested Lancaster County School Division Budget for FY10-11 as an annual appropriation.

Mr. Jenkins stated he still does not believe the school board has presented a good reason for the annual appropriation other than the fact that they had to pay for an additional template from Bright to get a report. The template is now in place and will not have to be paid for again.

Mr. Palin said he has knowledge first hand on how a specific report could be more helpful, rather than getting a report and needing to sift through the information to get what is actually needed.

Mr. Jenkins asked if the Board would be willing to make annual appropriations to every County department. Quarterly appropriations were put in place a few years ago and have been working. He stated he believes the Board of Supervisors needs more

information to justify why an annual appropriation would be better than a quarterly

appropriation. The Board has until July 1, 2010 to approve the way the funding should

be disbursed. This will give staff enough time to research the benefits, should changes be

justified.

Dr. Russell stated when the Board of Supervisors decided to go to the quarterly

appropriation there was a trust issue and he believes the superintendent and the school

board has earned that trust.

Mr. Jenkins said he agreed that both the superintendent and school board have

done a great job; however, the Board of Supervisors has set up a good system that has

been effective. He is only asking that this request be studied before the Board decides to

make changes.

Mr. Beauchamp asked Mr. Larson to report to the Board of Supervisors at the

next budget work session meeting on the pros and cons of continuing with the quarterly

appropriation versus an annual appropriation.

Mr. Geilich withdrew his motion to approve the local contribution as requested in

an annual appropriation.
