### **BUDGET CONSIDERATION**

### Northern Neck Free Health Clinic

Mrs. Nelson stated they expect to receive 4.5 million this year. The Virginia Commonwealth University School of Dentistry sent student interns to the clinic. They are requesting \$75,919 this year.

#### <u>Sheriff</u>

Sheriff Crockett said he would like a supplement for sworn deputies to increase to \$2,500 each.

# **Commonwealth Attorney**

Mr. Schmidt stated they have approval for an Assistant Commonwealth Attorney and Secretary and need to replace the telephone system. He asked about the health insurance and premium for this year.

# **<u>Clerk of the Circuit Court</u>**

Mrs. Kennedy asked for level funding this year.

### **Fire Departments**

The volunteer fire departments had some membership issues and they are requesting a total of \$100,000 for each fire department.

#### **Community Services Board**

Mr. Walsh stated they are continuing to serve Lancaster citizens by providing the necessary services. The region is currently at \$7.28 per capita. He would like to develop children services.

### **Department of Social Services**

Mrs. Davenport stated it has been over four years since they have received an increase.

#### The Haven

Mr. Kauders stated most of their funding is from Department of Social Services and Department of Criminal Justice Services. They are asking for an increase of \$1,000 funding this year.

### **Community Library**

Mr. LeHardy stated replacement of primary server is needed. They are requesting an additional \$13,900 increase this year.

### Northern Neck Tourism Council

Mrs. Long discussed the both the Antique Trail and Wine Trail. She is requesting an increase of an additional \$7,500.

### Soil and Water Conservation District

Mr. Berger stated there was no increase in their budget for eight years, however; he is asking for a \$5,000 increase for this fiscal year.

## Virginia Quality Life

Mr. Monroe requested funding in the amount of \$25,000 per year.

# **Refuse Disposal**

Mr. Rowe requested an additional funding, because of the administrations plan to improve the scrap iron and white goods collection at the Lancaster Convenience Center.
