1. <u>Virginia Retirement System Resolution</u> – Mr. Pleva presented the board with a resolution setting school board contributions and the VRS rate.

Mr. Pleva stated the resolution is required by the Commonwealth and formalizes the position of the Board of Supervisors with respect to the Employee Paid Member Contribution and the Employer Retirement Contribution Rate. Lancaster County Schools were also given the authority to proceed with immediate implementation of the 5% contribution which is the purpose of the special call meeting. The resolution as presented would have the employee paying 5% of his or her salary into the Virginia Retirement System. Also, as required by law, there would be a corresponding 5% increase in the employee's salary effective July 1, 2012 to offset the contribution. Both would be effective July 1, 2012.

Mr. Bellows made a motion to Approve the Virginia Retirement System (VRS) Resolution for Local Governing Body Concurrence with School Division Electing to Pay the VRS Board – Certified Rate. The school division will have the employee paying 5% of his or her salary into the Virginia Retirement System with a corresponding 5% increase in the employee's salary. Both would be effective July 1, 2012.

145(I) resulting from the June 30, 2011 actuarial value of assets and liabilities (the "Certified Rate"); and

BE IT ALSO RESOLVED, that the County of Lancaster (Employer Code # 55151) does hereby certify to the Virginia Retirement System Board of Trustees that it concurs with the election of the Lancaster County Public Schools to pay the Certified Rate, as required by Item 468(H) of the 2012 Appropriation Act; and

NOW, THEREFORE, the officers of the County of Lancaster (Employer Code # 55151) are hereby authorized and directed in the name of the County of Lancaster to execute any required contract to carry out the provisions of this resolution. In execution of such contract which may be required, the seal of the County of Lancaster, as appropriate, shall be affixed and attested by the Clerk.
