Mr. Jenkins called the meeting to order at 7:00 p.m.

PUBLIC INPUT

County Health Insurance

Dawn Mahaffey, Social Work Supervisor for Lancaster County Department of Social Services, stated she was representing a group impacted by the Board of Supervisors decision to award the 2006-07 health insurance coverage as a Single Employee Trust (SET). She provided the board with a memorandum, along with supporting documentation of research for the board's review. She stated that the group has several concerns and specific questions about the Single Employee Trust and the action taken by the board when selecting and implementing the plan. She said the group believes they have the right to have their questions and concerns answered. Their concerns includes the following: 1) the reduction in coverage under the SET Plan, 2) the immediate financial impact of increased out-of-pocket expenses, and 3) the potential for fraud and abuse in SET Plans especially for those where sending financial contributions to an out of state bank account. There is a recommended five stage process for establishing self insurance plan and the group would like to know if the board followed those steps and whether other SET Plans not requiring out of state deposits where considered and evaluated prior to Board of Supervisors awarding the contract to American Benefits Administrative Services (ABAS). She understands that this group is well below the industry standard for a SET Plan, in terms of membership and they are wondering how the viability of such a small group was established and by whom. And, finally what guarantee does the county have that the stop/lost insurance is actually in place. What company is the Lancaster County Health and Welfare Benefit Plan stop/lost provider?

Martin Shirilla stated he is a county employee and would like to give the board a highlight of how the switch to the SET Plan has affected him. He stated last year he and his wife were paying an average monthly cost for health insurance coverage and maintenance drugs of \$655.00, however; this month he is paying \$865.00. He stated he along with every other employee did a detail health survey and providing this information to the insurance company so they could get their numbers together for the board and they were given an extra month. He stated he has a specialist he was seeing four times a year now he goes only twice a year and this specialist diagnosed him with Attention Deficit Disorder (ADD) at the age 45. He said he had to have his medication changed from a name brand that worked for him, back to a genetic Ridalin which is not effective. He stated he will pay approximately \$942.00 in September for premium and maintenance drugs which will not include doctor visits or lab work. He stated he will need to pay

\$125.00 to see his specialist versus \$25.00. Why can't the Virginia Association of Counties (VACo) get together and work up a group plan, become part of a bigger group including the school system to get better group rates.

Debbi Harvey, Office Manager for the Department of Social Services stated in addition to the other concerns she has three additional concerns. She provided the board with her statement and attachments. She stated her first concern is that to date no one has received a written policy. Secondly, the U.S. Department of Labor has informed her that this is not an Employee Retirement Income Security Act (ERISA) Plan; therefore we have no federal rights or protection and the Virginia State Corporation Commission said we do not have any state rights or protection. Lastly, she was extremely alarmed as the county administrator stated there was no signed contract yet, even though we have sent over \$86,000 to Tampa, Florida over the last two months. As an employee and taxpayer, she would like to know where our money is being held, who has control over the money, how is it being protected against potential fraud and abuse? She asked to Board of Supervisors to meet with employees and answer questions.

Mr. Schmidt, Lancaster County Commonwealth's Attorney stated all of the Constitutional Officers and a great number of employees were available to show their support. He has concerns like the other county employees. His family feels their financial and physical health is in jeopardy. He provided the board with his statement and concerns.

Request for a traffic signal at the intersection VSH 688/James Jones Memorial Highway and VSH 200/Irvington Road

Mr. Balderson stated they still have not received the traffic signal study results for the intersection of James Jones Memorial Highway/Irvington Road.

Central Region

Mr. Balderson informed the board that they are now under the Central Region out of Richmond rather than the Fredericksburg District.

VSH 638/Blueberry Point Road

Mr. Balderson said the speed limit study of VSH 638/Blueberry Point Road has been completed and the 25 mph speed limit signs have been posted.

Taylor's Creek Project

Mr. Balderson stated that the Taylor's Creek Project was progressing along with no problems.

Wal-Mart Traffic Study

Mr. Beauchamp said a couple of months ago the board requested a traffic study about the impact of potential Wal-Mart traffic. He said the county has not received any study results.

Mr. Balderson stated he would ensure that the board would receive that information.

Speed Study Request/Town of Weems

Mr. Beauchamp stated he received a petition signed by 64 citizens requesting a speed study in the Town of Weems.

Mr. Jenkins stated there are legitimate concerns as traffic will be coming to Wal-

Mart from three separate directions. Traffic will be coming from east on VSH 3, east &

south on VSH 600, and from VSH 200 in Downtown Kilmarnock.

Mr. Jenkins asked VDOT to do a study on the configuration of the intersection at

VSH 3/Mary Ball Road and VSH 600/Courthouse Road.

Mr. Jenkins said there has been an accident and number of near misses at the

intersection of VSH 3/Mary Ball Road and VSH 620/Old Orchard Road.

Oak Point Drive

Mr. Pennell stated a resolution has been prepared to accept Oak Point Drive in the

Oak Hill Subdivision into the secondary system of highway.

Mr. Palin made a motion to adopt the following resolution to accept Oak Point

PUBLIC HEARINGS

Application for Special Exception, Individual Manufactured Home – Tynesha
 <u>Davenport</u> – Mr. Larson presented an application for special exception by Tynesha
 Davenport to place an individual manufactured home on property identified as Tax
 Map #13-142. The subject property is off VSH 618, Nuttsville Road, near
 Nuttsville, Virginia in Voting District 2.

Mr. Larson said Ms. Davenport has met all the requirements to place her home and has certified that she will occupy the home.

2. County Building – 201 School Street, Kilmarnock (formerly the YMCA Building)

– Mr. Pennell stated the YMCA has finally relinquished its occupancy of the county building located at 201 School Street, Kilmarnock, next door to the Lancaster Community Library. Ms. Collins, Director of the Lancaster Community Library, stated they are still interested in utilizing the building. The building will be used as a home base for the story mobile staff as the library activities continue to grow.

3. <u>High School Wastewater Repairs</u> – Mr. Pennell stated recently, school administration forwarded additional invoices (Rancorn Wildman - \$5,128.15 and GET Solutions - \$1,841.00) for payment for work that has been completed on the high school's wastewater repairs and canopy construction. These expenses have not yet received a supplemental appropriation from the Board of Supervisors.

Mr. Pennell said it appears that the engineering/architectural services have a contract price of \$42,400 but to date only \$34,528 has been appropriated by the Board of Supervisors for these services. He is uncertain if the October and January appropriations of \$6,900 and \$139.47 (included in the \$34,528) are part of the \$42,400 cost for Rancorn Wildman's fees. It also appears there are "reimbursable expenses" as part of the contract that are outside the cost of the professional services. He said he was also unaware of the purpose for the GET Solutions invoice. He requested that a representative of the school administration/board be present to answer questions but no one is present.

By consensus of the board, defer this issue until the school administration/board is available to explain the expenses for appropriations.

4. <u>Transfer of Capital Improvement Funds – County Cash Flow</u> – Mr. Pennell stated he received a memorandum from the Treasurer describing the need for a cash advance to accommodate the county's end of August/beginning of September financial needs.

Mr. Jenkins made a motion to ratify the county administrator's transfer of \$864,000 from Capital Improvement Funds to the General Fund to provide the cash flow needed for the county's end of month/beginning of month expenses.
