# PUBLIC INPUT

# VSH 604/Merry Point Road and VSH 611/Hoecake Road Alignment Project

Charles Costello, District 2, noted that VSH 604/Merry Point Road and VSH 611/Hoecake Road project has been completed; however, in the curve there is a six to seven foot deep covert. There is also a deep covert behind the stop sign. He stated VDOT may need to erect guardrails.

Mr. Beauchamp asked Mr. Harper to look at the intersection and review the request.

### VIRGINIA DEPARTMENT OF TRANSPORTATION

#### VSH 777/Riverview Road Project Delay

Mr. Harper said VSH 777/Riverview Road Project has been moved to the Spring 2013, because it is so late in the year and unpredictable winter weather.

### VSH 604/Merry Point Road and VSH 611/Hoecake Road Alignment Project

Mr. Harper stated the VSH 604/Merry Point Road and VSH 611/Hoecake Road Alignment Project has been completed on time and on budget. Some improvements made were the increased pavement width from 20 to 24 foot and improved sight distance in both directions. He stated he would take Mr. Costello's concerns and request to Mr. Brown.

#### Stop Sign Concerns

Mr. Jenkins stated at VSH 354/River Road at Ottoman Ferry Road there is difficulty recognizing where the stop sign is located. There a similar problem at the intersection of VSH 622/Morattico Road and VSH 3/Mary Ball Road near Lancaster Auto and Marine.

Mr. Harper asked if he believed the problem could be resolved with reflectors on the post stop signs.

Mr. Jenkins said that would be helpful.

## VSH 600/Courthouse Road and VSH 3/Mary Ball Road

Mr. Palin thanked VDOT for removing the trees at the intersection of VSH 600/Courthouse Road and VSH 3/Mary Ball Road making visibility better.

#### **PUBLIC HEARING**

 <u>Application for Special Exception – Eric J. Malmgren</u> – Mr. Gill presented an Application for Special Exception by Eric J. Malmgren to place a data antenna/pole under 100 feet tall for wireless Internet access on a 12.058-acre parcel described as Tax Map #27-140A. This property is zoned R-1, Residential General and is located at 2175 Weems Road (VSH 222) in District 5.

Mr. Gill stated Article 5-1-23 of the Lancaster County Land Development Code allows the placement of data antennas with a special exception. This is a continuation of requests for special exception consideration to locate data antennas at various locations within the county to provide wireless broadband Internet access in areas lacking that capability.

Mr. Gill said there are no zoning issues with the location of this antenna/pole. It has the potential to serve many homes in the Weems area.

Mr. Gill stated this request has been advertised and adjoining property owners notified as required by law. To date, there has been no response from the public.

Chairman Beauchamp opened the public hearing.

Hearing none, Chairman Beauchamp closed the public hearing.

Mr. Beauchamp made a motion to Approve the Application for Special Exception by Eric J. Malmgren to place a data antenna/pole under 100 feet tall for wireless Internet access on a 12.058-acre parcel described as Tax Map #27-140A located at 2175 Weems Road (VSH 222).

Greentown/Gaskins Road Community Improvement Project – Local Business and Employment Plan Adoption – Mr. Pleva stated the county previously published the Local Business and Employment Notice which is a requirement of the Community Development Block Grant (CDBG) program. 3. <u>Greentown/Gaskins Road Community Improvement Project – Program Income</u> <u>Plan Adoption</u> – Mr. Pleva stated the Community Development Block Grant (CDBG) Program requires the adoption of a program income plan, which identifies the ways and means that income (non-county) generated during project and after closeout of the project will be collected, tracked and used. Essentially, program-generated income must be utilized to further the CDBG activities within the project area or CDBG activities within the jurisdictional boundary of Lancaster County.

 Greentown/Gaskins Road Community Improvement Project – CDBG and Scattered Site Grant Funds – Establish Separate, New Accounts and Appropriate \$100,000 of Local (Reimbursable) Funds per Account – Mr. Pleva stated the county must establish two, new but separate accounts for the Community Development Block Grant (CDBG) Program and Scattered Site Projects as well as appropriate \$100,000 of local funds from the General Fund Operating Reserve to each account. These accounts will be used to receive and disburse CDBG funds for project-related expenses. Since these projects operate on an expensereimbursable basis from the grantor agencies, a \$100,000 appropriation of local funds from the General Fund Operating Reserve to each account is needed.

Mr. Lee made a motion to Approve the Appropriate of \$100,000 of Local (Reimbursable) Funds, Establish Separate and New Accounts for Greentown/Gaskins Road Community Improvement Project and Scattered Site Grant as required.

5. <u>Greentown/Gaskins Road Community Improvement Project – Wastewater</u> <u>Collection and Treatment System Connection Fee</u> – Mr. Pleva stated the Board must establish connection/hook-up fees for those households that may connect to the project's wastewater collection and treatment system, but are either not low or moderate income or not located in the project area. Connection fees will be waived for low and moderate income households that participate in the CDBG Project.

The Project Management Team met on November 7, 2012 and considered a connection fee schedules of several jurisdictions in the region including Mathews, Urbanna, West Point, King William, Tappahannock, Kilmarnock, Westmoreland County (including Montross), Gloucester County and Northumberland County as well as the annual statewide survey of water and wastewater connection and user fees prepared by Draper Aden Associates. The following connection fee schedule recommended by the team to be adopted and become effective upon adoption:

*Fee Per Equivalent Dwelling Unit - \$6,000 (applicant also pays full cost to physically connect his/her dwelling to the wastewater system)* 

Discount: Fee Per Equivalent Dwelling Unit for Applications Received Prior to December 31, 2012 - \$4,500 (applicant also pays full cost to physically connect his/her dwelling to the wastewater system)

The discounted fee is intended to encourage households that are not project beneficiaries to connect to the wastewater system, thereby increasing the number of system users (customers). This should financially benefit the operation and maintenance of the wastewater system.

The Board may periodically review and, if deemed necessary, adjust the wastewater system's connection fee.

Mr. Lee made a motion to Adopt the Wastewater Collection and Treatment System Connection Fee as recommended by the Project Management Team for the Greentown/Gaskins Road and Scattered Sites Community Improvement Project.
